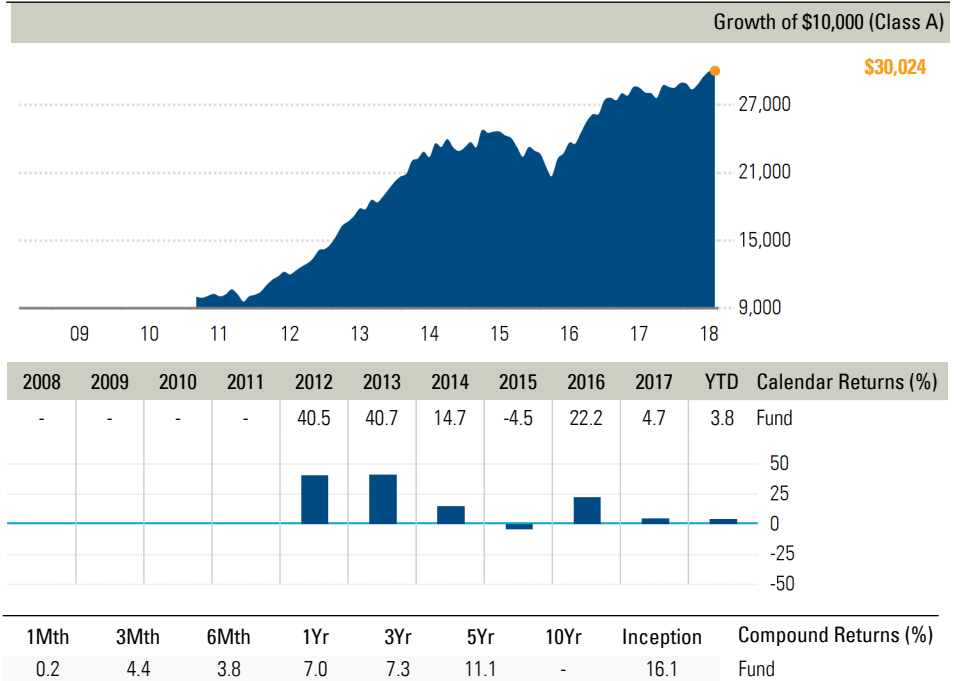


### Investment Objective
