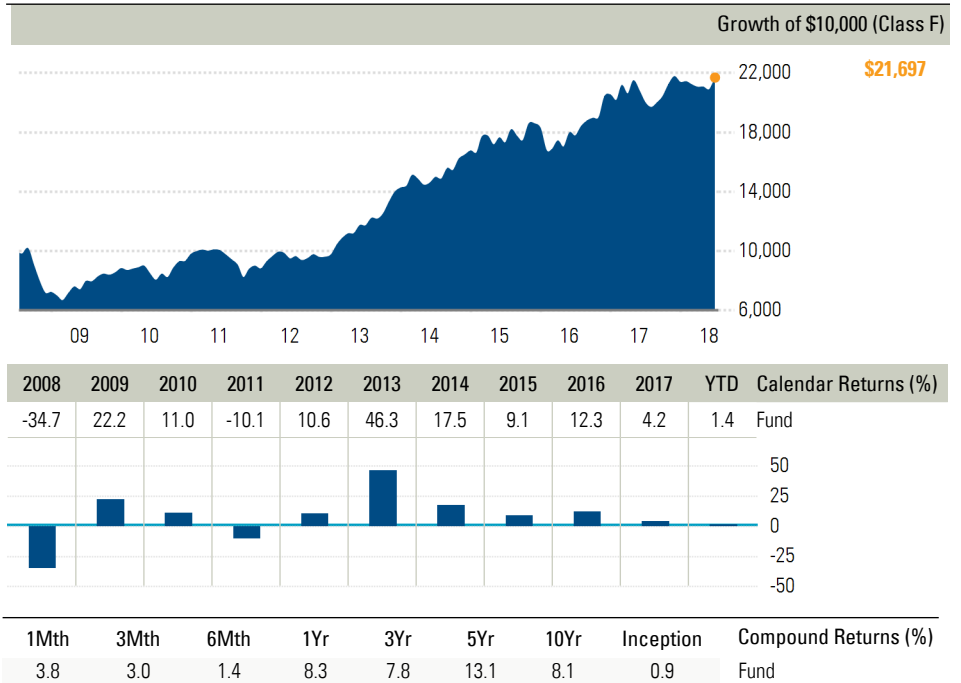


Investment Objective
