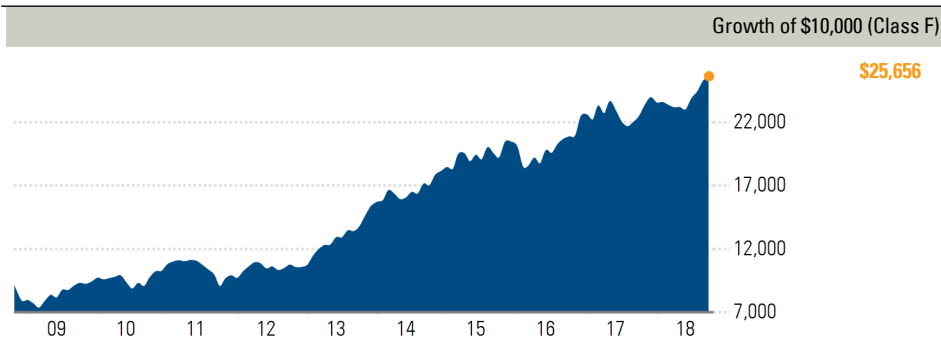


Investment Objective
