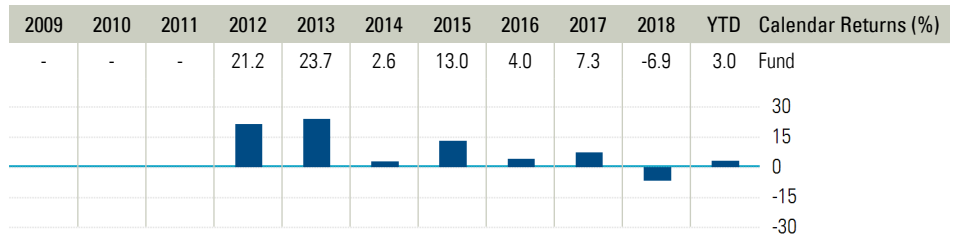
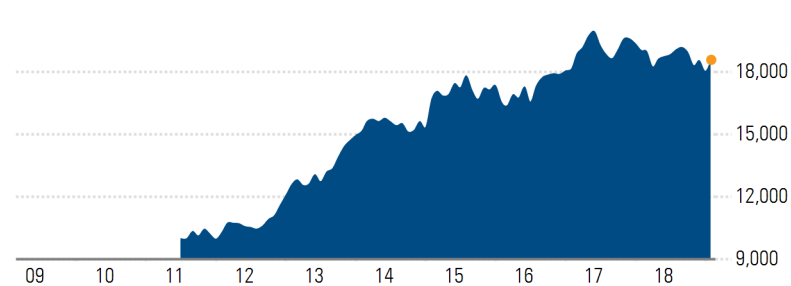
Investment Objective
