Investment Objective

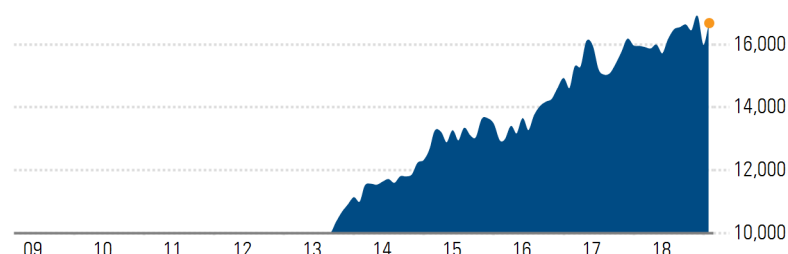
