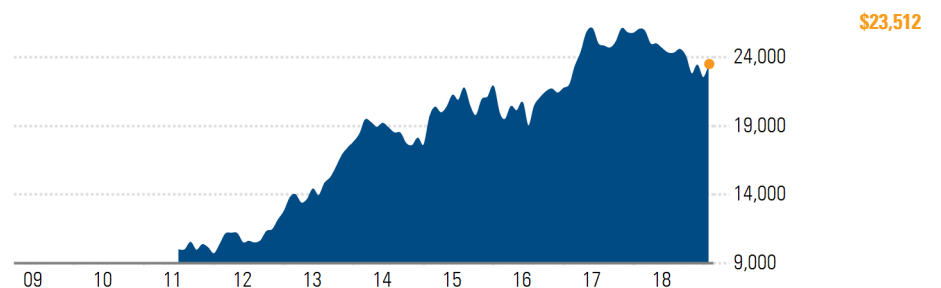
Investment Objective
