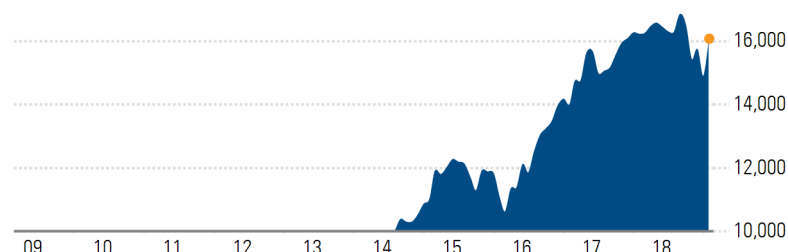
The investment objective of this fund is to provide long-term capital growth by investing primarily in common shares of companies located anywhere in the world.



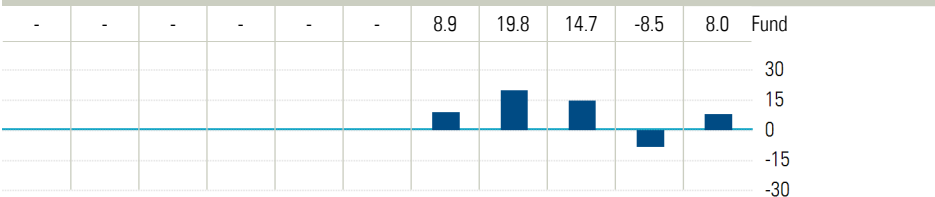
Portfolio Performance
