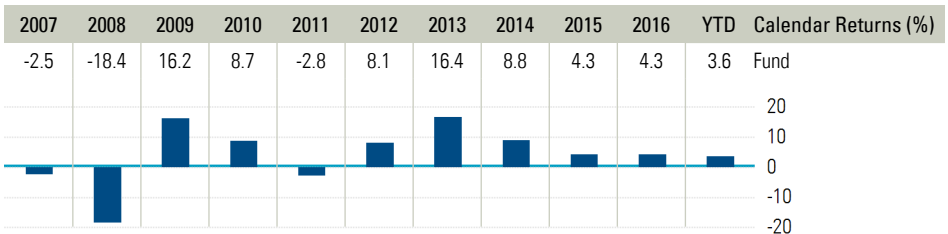
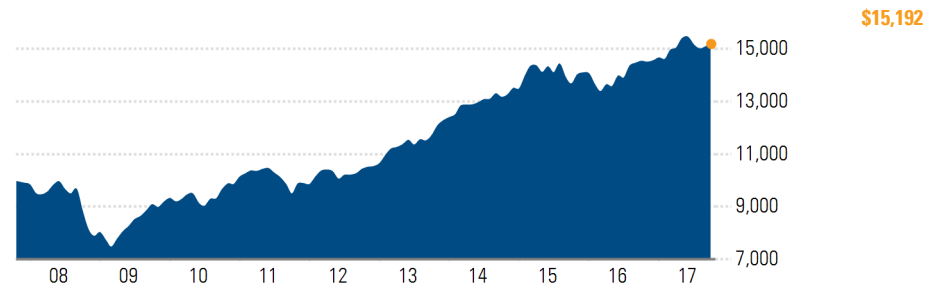
Investment Objective
