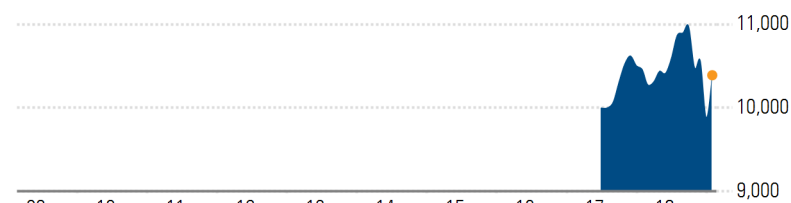
Investment Objective
