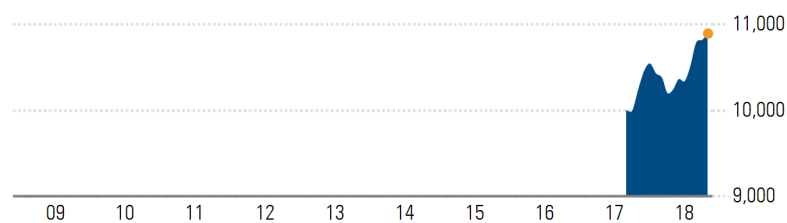
Investment Objective
